The Dan Laubacher Memorial Scholarship Foundation was established to carry on Trooper Laubacher's dedication and service to the field of Criminal Justice and Law Enforcement. The Foundation is intended to further continue Trooper Laubacher's passion for bringing awareness to students of all ages concerning safety both on and off the road and to leave an impressionable mark on the outcomes of the decisions they make.

Trooper Laubacher, a resident of Jackson Township, was a graduate of Perry High School in 1992 and joined the Wooster post of the Ohio State Highway Patrol after graduating from the academy in 1999. During his tenure with the Highway Patrol, Trooper Laubacher worked frequently as a school liaison officer where he developed his passion for educating and working with students.

An annual scholarship will be awarded to a student pursuing an education in criminal justice, law enforcement, or a related field.

Application Requirements:

- Students who apply must be pursuing a career in the field of Criminal Justice, Law Enforcement, or similar field of study at a post-secondary institution
- The value of each scholarship is a one-time award of \$1,000.
- The scholarship is awarded directly to the students' academic institution in his/her name.
- Applicant must be under the age of 25.

Applications (including Essay, Transcripts and Letter of Recommendation) must be received by the Foundation no later than April 15, 2017 **(No late applications will be accepted)**.

Part IV – Letter of Recommendation:

Please have a letter of recommendation prepared and submitted on your behalf by an individual who has had a positive impact on your life in some way. The letter writer must explain to the Foundation why you will benefit from the scholarship and how you will be a benefit to the field of Criminal Justice and/or Law Enforcement.

The letter of recommendation must include the writer's name, address, and phone number. The letter must be submitted to the Foundation directly by the writer prior to the application deadline. The person submitting the letter cannot be a family member. Please make sure the writer is aware that they may be contacted by the Foundation.

All contents of the application, transcripts, essay, and letter of recommendation will remain confidential and are not subject to review by anyone outside of the Foundation.
