WHAT IS THE TIME PERIOD?

The 2017 Faculty and Staff Annual Fund campaign begins on August 21 and ends October 13, 2017.

WHY PARTICIPATE?

The Faculty and Staff Annual Fund is an important part of who we are here at Stark State College. Everyone works directly or indirectly for the students. There are students in our classrooms, online, and on campus who benefit from your Foundation donation for scholarships. This is your opportunity to make a financial investment *in our students* especially when 100% of your donation is applied to the fund you have indicated. Your participation in our Faculty Staff Annual Fund will not only provide student scholarship assistance, it will provide an advantage in attracting additional external donations which ultimately supports student completion, retention, as well as recruitment. WHAT'S THE GOAL?

The goal is to reach **63% participation!** Last year we achieved 62% employee participation and raised over \$51,000-praiseworthy, but together we can increase both our total participation and total donations. For example, if every employee donated \$5.00 a pay for the next calendar year, this would equal \$130 annually and our internal giving would exceed \$100,000 in total annual donations. **Every donation creates fuel for scholarships.**

WHAT SHOULD I GIVE?

Each person should decide what is right based on individual capability. Whether this is \$5.00 a pay or \$25.00 a pay, it helps our students and brings us closer to our goal of 63% participation. Help us "Refuel for Fall" by donating today.

WHERE DOES THE MONEY GO?

Over the past 22 years, the Stark State College Foundation has given over **\$3 million** in scholarship funds to over **9,500 students**. During fall 2016/ spring 2017 academic year, the Foundation raised over \$1,083,351 for student scholarships, college projects, programs and instructional needs.

WHAT IS AN ENDOWED SCHOLARSHIP AND CAN I ESTABLISH ONE?

An endowed scholarship is a permanent charitable scholarship invested with a long-term strategy in order to provide income into perpetuity without invading the principal. A tax-deductible donation of \$5,000, payable over five years or less will establish an endowed scholarship in your name or a loved one's name. Your \$39 payroll deduction each pay for five years would achieve the \$5,000 endowment donation. Contact Brenda Griffith at Ext. 4415 for more information.
