Explanatory Notes

“Providing additional emergency financial aid grants to students.” included cash assistance which has been prioritized for students with financial need which were affected by the ongoing disruption of campus operations due to the coronavirus pandemic. Students filed an application and were approved for funding to assist with their costs of attendance. Students were given the option to apply funds to their account balances at their discretion in accordance with Department of Education Guidance.

“Costs related to operating additional class sections to enable social distancing, such that those for hiring more instructors and increasing campus hours of operations.” included the additional pay for instructors and lab personnel to add additional hours for laboratory activities due to limiting the number of students in the lab at one time (i.e. they could not use the rooms to full capacity during the normally scheduled hours of the class, so additional hours were made available to the students at an alternate time to complete their assignments). This category also included hiring more instructors to teach additional sections of courses which were necessary to meet student demand when the class sizes were limited due to social distancing requirements.

“Campus safety and operations.” Included PPE, safety, and sanitation costs that were not previously budgeted by academic departments.

“Purchasing, leasing, or renting additional equipment or software to enable distance learning, or upgrading campus wi-fi access or extending open networks or parking lots or public spaces, etc.” included software such as Respondus Lockdown Browser driven by expanded use of distance education, and remote services provided by third parties to replace in person clinical experiences in the allied health field that were not possible when clinical affiliates suspended student participation. Additional computer equipment and other academic equipment was also purchased to assist with teaching and to accommodate distance learning including materials kits for dual enrollment students taking online courses.
