

## FEDERAL DIRECT PARENT PLUS LOAN APPLICATION INSTRUCTIONS 2022-2023

The Federal Direct Parent PLUS Loan is a Federal loan program for parents of college students. Before applying, you should review the information regarding the Federal Direct Parent PLUS Loan provided at [www.starkstate.edu/PLUS](http://www.starkstate.edu/PLUS).

To apply for a Federal Direct Parent PLUS Loan, the parent must complete the following steps:

**Step 1:** Complete this 2022-23 Federal Direct Parent PLUS Loan Application and submit it to Gateway Student Services.

**Step 2:** Complete the Federal Direct Parent PLUS Loan Master Promissory Note (if you have not completed one previously). The applying parent will be required to sign in using their Federal Student Aid ID (FSA ID) and password.

To complete this requirement:

1. Go to [www.studentaid.gov](http://www.studentaid.gov)
2. Click on the **Parent** tab
3. Click on **Complete a Master Promissory Note (MPN) for a Parent PLUS Loan**
4. In the **I'm the Parent of an Undergraduate Student** section, select **Log in to Start**.

### Checking on your application

The Parent PLUS Loan Application can be seen on the student's MyStarkState account.

The student can check on the status as follows:

1. Log into **MyStarkState** at [www.starkstate.edu/mystarkstate](http://www.starkstate.edu/mystarkstate).
2. Click on the **My Stuff** tab.
3. Click on **Financial Aid Home** button.
4. Select **"2022-2023"** from the drop-down menu.

On the Home page, the Parent PLUS Loan Application will be listed along with the current status.

**Received Not Yet Reviewed:** The Federal Direct Parent PLUS Loan Application has been received, but not yet been reviewed.

**Incomplete:** Required information on the Federal Direct Parent PLUS Loan Application is missing. Please contact the Financial Aid Office for additional information or instructions.

**Denied:** The parent's PLUS application was denied by the U.S. Department of Education due to adverse credit.  
*- If the parent's PLUS application is denied by the U.S. Department of Education the student may request an additional unsubsidized loan by completing a Federal Direct Loan Authorization Form.*

**Approved:** Your parent's application for the PLUS was approved.

Once the loan has been processed and approved, go to the **Award Offer** tab to view the amount for which the loan was approved. It is important to note that the amount requested may differ from the amount awarded based on the cost of attendance and other awarded financial aid. A fee of 4.228% loan origination fee is deducted from the award amount when funds are disbursed. Loan origination fee subject to change October 1, 2022.
