Licensed practical nurses (LPNs) work in all medical areas such as hospitals, schools, nursing homes, health care clinics and home care. Upon completion of the program, graduates will receive a certificate of completion and will then be eligible to sit for the NCLEX PN exam to receive licensure.

Stark State College Practical Nursing offers day and evening/weekend programs. The Day Program allows a spring and fall semester start with classes, practice lab, and clinicals held Monday-Friday. There are 46 seats available with each new cohort. The Evening/Weekend Program allows a spring start with class and practice lab 1-2 evenings a week and clinical experiences on Saturdays. There are 30 seats available with each new cohort. All Practical Nursing (PN) classes and labs are held at the Akron Perkins campus. Clinical experiences are at healthcare facilities within a 75-mile radius.

Once you are ready to get started on your pathway to nursing, you will first need to follow the **6 EASY STEPS for new student enrollment**. Admission advisers at the Gateway Center would be glad to help you. You can set up an appointment to get started on the Admissions website: <https://www.starkstate.edu/admissions/>. Please let them know at that time that you are interested in pursuing a **Practical Nursing major**.

**Initial Requirements for the PN program:**

1. Proficiency requirements:
  - \*IDS102 with B or better (or proficiency [Accuplacer Reading Score 246+])
  - \*MTH022 with B or better (or proficiency [Accuplacer Math Score 250+])
  - \*May also be determined by ACT scores or transcripts
2. Post-secondary GPA of 2.0 or greater. If no post-secondary GPA, a HS GPA of 2.0 or greater is required.
3. FBI/BCI Background check through Stark State Security **Valid for 1 year**  
You must obtain a background check from Stark State Security. If applicable, contact the Program Coordinator for a list of offenses that may exclude a student from attending the program. The cost of the FBI/BCI background check is \$70. Appointments are required. 4. TEAS Test – 58.7 percentile or higher **Valid for 3 years**  
The test covers Math, Science, Reading, and English/Language. Study material is available for purchase at [www.atitesting.com](http://www.atitesting.com). The test can be taken more than once – the PN program does not limit the number of times the test is taken or the time frame between taking the test – although applicants are encouraged to utilize remediation resources before retesting. 5. SSC101 and BIO101 (or equivalent) with a C or better. These courses may be completed during the 1<sup>st</sup> semester of the PN program. However, it is strongly recommended that they are taken prior to entering the PN program to ensure a successful foundation.

**\*\*Applicants must submit three (3) items (paper copies) to the Akron Gateway Center (Attn: PN Program Coordinator), to be considered for admission (emailed applications will not be accepted): completed PN application, background check email from SSC Security office, and TEAS test results. All items must be turned in together prior to the June 15<sup>th</sup> deadline for the Fall cohort or the December 1<sup>st</sup> deadline for the Spring cohort. The Admission Committee will review applications and notify applicants by their SSC email if they are accepted or declined for admission.**

Applicants may request a one-time Academic Forgiveness by completing the [Academic Forgiveness Form](#) and submitting the form to Academic Records/Registrar's Office. If granted, the applicant may proceed in the application to the PN program.

Applicant will receive an email of verification of eligibility through their SSC email. Please direct all background questions to the Security Office. For PN program have a copy of background sent to the Ohio Board of Nursing.

**Submit the following documents to Gateway Student Services at Stark State College, Akron Campus (Attention PN Program Coordinator) : completed application, passing TEAS score printout from ATI website, and the Stark State College Security email verifying BCI/FBI background check (emailed applications will not be accepted).**

The application **deadline for Fall admission is June 15<sup>th</sup>**. The application deadline for the **Spring admission is December 1<sup>st</sup>**. If the cohort is not filled, the Admission Committee may continue to review applications submitted after that date. Applicants who would like to be considered for the next cohort will need to resubmit the completed documents by the next deadline.

The SSC Practical Nursing program Admission Committee will review all completed applications after the deadline and notify all applicants through their SSC email, of their acceptance or denial.

Credit cards will be accepted.**
- **For PN program please make sure to select the Ohio Board of Nursing to obtain a copy of background check.**

#### **Guidelines for everyone's safety**

- Enter through door S1 (main entrance, Main Campus, S Building) where you will be required to check-in with the Security Desk.
- The background check station is located in S103.
- We ask that you arrive to your appointment on time and allow for extra time if you need to pay at the cashier's window.
